INVITATION FOR BIDS

The New Bedford Housing Authority (Authority), the awarding authority, invites sealed bids for the supply and delivery for **Door hardware Materials** including, but not limited to, Schlage removable cores, keys, blank keys, passage set, door levers, card reader, smart fob, padlocks, key cutting machine. The total estimated combined contract cost is \$130,000.

The New Bedford Housing Authority will award contracts to the responsive and responsible bidders offering firm fixed prices for the desired quality items at the best prices. The successful bidder will be required to deliver and warranty these items for a term of one (1) year on an as needed basis.

Based on Governor Baker's declared state of emergency, in-person bid openings are not required at the present time therefore bids will not be publicly opened. However, General **Bids will be received until 2:00 p.m., Wednesday, December 23, 2020** opened forthwith, read aloud, witnessed and the results distributed to all bidders by e-mail soon thereafter. All Bids should be sent to: the New Bedford Housing Authority Modernization Office, 128 Union Street - 4TH Floor, New Bedford, Massachusetts 02740 and received no later than the date & time specified above or may be sent electronically to ModTeam@nbha-ma.org, no later than the date & time specified.

Bid Documents will be available from the New Bedford Housing Authority Modernization Office, 128 Union Street - 4TH Floor, New Bedford, Massachusetts 02740 between the hours of 8:30 and 4:30, Monday thru Friday excluding holidays beginning on **Wednesday, December 9, 2020**. Bidders may obtain one (1) e-mailed set of Bid Documents by sending a request and their contact information to: ModTeam@nbha-ma.org.

Each bid must be accompanied by: a signed Form For Bids, a signed Certification of Non-Collusion, a signed Revenue Enforcement and Protection (REAP) Certification, and a signed U. S. Department of Housing and Urban Development (HUD) FORM 5369-C Certifications and Representations of Offerors - Non-Construction.

All bids for this supply are subject to the provisions of M.G.L. c.30B §5. No bid shall be withdrawn for a period of sixty (60) days upon opening of bids without the consent of the New Bedford Housing Authority. The contract will be awarded to the responsive and responsible bidder offering the lowest price for all items specified. The Authority reserves the right to waive any informalities or irregularities in any or all bids, or to reject any or all bids in whole or in part, if it be in the public interest to do so. The Authority will reject any and all bids when required to do so by the above referenced General Laws.
